Pre-Budget Consultations OPEN NOW

The Government has begun pre-budget consultations to hear from Canadians about what matters most as we prepare Budget 2024 - the next steps in our economic plan. Currently our economic plan is building more homes, faster while making life affordable and creating good jobs for Canadians from coast to coast.

Your input will help tailor our economic plan to ensure it addresses the challenges that matter most to Canadians and build an economy that works for everyone.

Multiculturalism and Anti-Racism Program

The fallout from multiple conflicts around the globe underscores the importance of Canada's values of multiculturalism and acceptance. That is why the Government is unveiling the new Multiculturalism and Anti-Racism **Program (MARP)** with funding to help organizations working to counter racial and cultural based discrimination. Applications are now open for Calls for Proposals for the Organizational Capacity Building (OCB) component of MARP.



The OCB Call for Proposals will focus on:

- Initiatives that strengthen connections between interfaith and intercultural communities
- Initiatives led by, or serving Indigenous, Black, racialized and religious minority communities, and communities with lived experiences of racism;
- Community-based organizations working to drive positive change; and Initiatives that reach rural and remote areas across Canada

Special Immigration Measures for **Extended Family Members in Gaza**

The current conflict in Gaza has and continues to inflict tremendous damage and suffering to innocents who are trapped by the conflict, and some of them are family members of fellow Canadians.

That's why in December of last year we announced special measures to apply for a temporary resident visa (TRV) for Palestinians who:

- live in Gaza
- are related to a Canadian citizen or permanent resident who lives or intends to live in Canada
- will be supported in Canada by the Canadian citizen or permanent resident for a period of 1 year

If you're eligible, your family members can also apply for a TRV under these measures.

These temporary measures came into effect on January 9th, 2024 and while an initial number of 1000 TRP's was mentioned, there will be flexibility on the actual number accepted. Minister Miller is quoted in the media as saying there is no hard cap on the number of TRP's.

Housing Accelerator Fund (HAF) Every city has its own housing needs. There's no one solution


