# Canadian Dental Care Plan Rollout

Following the announcement last year of the rollout of the Canadian Dental Care Plan (CDCP) there are some important details on who is eligible and how to apply.

#### To be eligible for the CDCP, Canadian residents must:

- Vot have access to any private dental benefits, including through employers, pensions or privately purchased plans
- Have an adjusted family net income of less than \$90,000;
- Be a Canadian resident for tax purposes; and
- Have filed their tax return in the previous year

Those who qualify are being invited by letter to apply to Service Canada. Each month Service Canada will contact a new group of seniors, based on age. Applications remain open for those 77 years or older and, as of February 1<sup>st</sup>, the CDCP expanded applications to seniors aged 72 and up. Seniors aged 70 to 71 will be eligible to apply in March 2024. Each person's eligibility will be checked on an annual basis for all those enrolled in the CDCP.

# Canada Revenue Agency to invest in free TAX CLINICS

Last year free tax clinics made it possible for more than 649,000 Canadians with modest incomes to file their taxes. Everyone should file a tax return, even if they have no taxable income - that's how people last year received receive more than \$1.75 billion in benefits, credits, and refunds. More than 3,400 community organizations, composed of over 14,700 volunteers participated in the **Community Volunteer Income Tax** Program (CVITP) in 2023.

This year, the CRA is looking for more community partners to lend a helping hand in their communities by hosting free tax clinics.

# National Action Plan to **End Gender-Based Violence**

Too many people continue to experience violence every day because of their sex, gender, gender identity, gender expression, or perceived gender. This is referred to as gender-based violence (GBV), and it is one of the most pervasive, deadly, and deeply rooted human rights violations of our time.

The federal government has established a bilateral plan working with all provinces and territories to help reduce GBV with a \$539.3 million investments over five years to supplement and enhance services and supports.

#### **Grow your BUSINESS ONLINE** GET UP TO \$2400

The Canada Digital Adoption Program (CDAP) has been helping tens of thousands Canadian smalland medium-sized businesses grow their online presence and adopt digital technologies.

Our government has been committed to ensuring that all Canadian businesses benefit from the digital economy – whether it is a mom and pop shop creating their first website, or a manufacturing company integrating AI into their operations.

Businesses can apply for a microgrant of up to \$2,400 through the **Grow Your Business Online** (GYBO) grant.

This means that businesses that want to expand their online activities, including adopting e-commerce, digital marketing and upgrading their cybersecurity are encouraged to apply under this stream.

#### **Government announces**

As part of our efforts to fight housing shortages for Canadians, the government is providing a \$98.6 million top-up to the Canada Housing Benefit (CHB) to support low-income Canadians by providing direct payments to help them with their rent.

These contributions to the CHB go directly to renters though provincial and territorial rent programs. The government is also providing \$100 million in emergency winter funding as part of our Reaching Home strategy to reduce houselessness. This funding will help 85 communities across the country provide more shelter spaces, temporary rental assistance, warming spaces and meals to those struggling with houselessness.
